The data presented in this publication is a required annual report of activities of the feed regulatory program. The report includes sample analyses and tonnage reports from the 2009 calendar year. The intent of this information is to provide those interested in feed products distributed in Kentucky with activities and information that can serve as an advisory tool.

Introduction

The Kentucky Commercial Feed Law of 1972 (KRS 250.491 to 250.631) provides protection for the state's feed manufacturers, the livestock and poultry industry, pet owners, and other purchasers of feeds. The feed law regulates any material offered for sale as feed or for mixing into a feed. However, whole and unprocessed commodities, raw meat, hay, straw, stover, silage, cobs, husks and hulls, when unground and not mixed with other material are exempt. Regulated products can include any product that is provided for consumption by any living animal that provides nutrients and/or energy for growth, development, reproduction or maintenance like pet foods, companion animal treats, livestock minerals, complete animal and poultry feeds, protein blocks, supplements, feed ingredients, and other premixes used for further manufacture of feed.

The information in this report will inform the feed purchaser, provide an atmosphere for fair and equitable competition, and assist in assuring the safety of animal and human food. Generally, before products are distributed in Kentucky they require a review of the label that includes guarantees, a list of ingredients, feeding directions, and absence of any false or misleading claims. Feeds containing medications undergo review for approved drug claims, dosage and usage, statement of purpose, any required warning or caution statements, and special feeding instructions. Currently, there are about 13,000 products registered for distribution in Kentucky.

Verification of good manufacturing practices (GMP's) and evaluations for cleanliness and housekeeping are handled with feed mill inspections. A major aspect is to prevent passing on to animals any unsafe, contaminated or adulterated feeds that could enter the human food chain. These inspections also check on confirmation to US FDA regulations for handling, storing and mixing drugs.

Inspection and Sampling

Tables 1 through 3 provide information on the number and type of feed ingredients and products sampled for the last 3 years.

Feed Mill Inspections

The medicated feed mill program currently has two classifications. Mills that mix Category IIType A medicated feed articles must be licensed with FDA, and mills that mix drugs commonly are exempt and do not require a FDA license. Most mills in Kentucky mix only exempt drugs. However, all feed mills must comply with good manufacturing practices (GMP). Inspections for this purpose help ensure approved drug levels, proper mixing procedures, feed ingredient monitoring, good recordkeeping, and good housekeeping protocols, which insures safe feeds for animals in the human food chain.

BSE Rule Inspections

The Division participated in a program to conduct 75 inspections that followed FDA guidelines and rules to ensure compliance with the BSE Rule. These rules are in place to prevent the establishment and amplification of Bovine Spongiform Encephalopathy (BSE), sometime referred to as "Mad Cow Disease". The rules and regulations prohibit feeding certain meat derived proteins to ruminant animals. Feed mills that receive prohibited ma-

terials must utilize adequate procedures to prevent any chance of those materials getting into feeds for ruminants. All feeds that may contain prohibited material must bear the cautionary statement, "Do not feed to cattle or other ruminants."

Food Safety

Keeping feeds free of contamination concerns feed manufacturers and regulatory officials because of the potential impact of contamination on the Kentucky livestock industry and the potential carryover to human food. The ultimate goal is prevention. Feed industry personnel involved in receiving ingredients, manufacturing feeds, and distributing feeds are very important in maintaining a safe feed supply. Occurrences that need attention may be abnormal appearance of the feed, an unusual feed odor, or presence of foreign material. Immediate attention and investigation is warranted with multiple livestock sickness or deaths and when chemical leaks occur. Regulatory Service inspectors and laboratory staff are available to assist with any investigation of suspected problems. Frequent inspections, product sampling and analysis, label reviews, drug testing, mycotoxin testing, feed microscopy, and GMP activities support efforts to maintain a safe food supply.

During 2009, mycotoxins (vomitoxin) in barley, oats and wheat, and the resulting feeds were a concern as fungal diseases were more prevalent. The period of corn harvest for the 2009 crop was wetter than normal resulting in increased levels of fumonisin in 26 of 46 grain samples taken across the state.

Testing and Product Suitability

The feed laboratory provides the primary analyses of the nutrients and other components in feed samples obtained by the inspection staff. Data from the laboratory is used to evaluate suitability of product labeling, and absence of either adulterants or deleterious substances. Table 4 lists the number of various analyses reported.

Data from the laboratory analysis are also compared to information from the National Research Council (NRC), the Association of Feed Control Officials (AAFCO), and University of Kentucky researchers as a basis for evaluating nutritional suitability for the intended use of a feed. Labels on dog and cat foods must include a nutritional adequacy statement based on the AAFCO nutrient profile.

Feed Labeling

A feed label is the fundamental communication with the consumer; it provides information, protection and the regulatory foundation. Providing labeling assistance and guidance to product registrants and manufacturers has been beneficial in promoting safety and usefulness of feeds for livestock and companion animals. A full-time registration specialist reviews product labels for compliance with applicable Kentucky and federal laws and regulations. The inspection staff often assists local feed manufacturers with labeling, resulting in more uniform and informative labels. Spreadsheets are available to assist in establishing label guarantees and for estimating nutritional suitability of some custom mixed feeds. These services provide strength for an excellent working relationship with the feed industry in Kentucky.

Financial

The feed regulatory program is supported by inspection fees of the commercial feeds sold in Kentucky and some state-appropriated funds. A fee of 35 cents per ton is paid on commercial feeds packaged and sold in containers greater than 10 pounds. Distillers wet grains, distillers products with more than 75 percent moisture, whey, and brewers wet grains distributed without further processing to the final purchaser pay a fee of 5 cents perton. Products sold exclusively in packages of 10 pounds or less pay an annual registration fee of \$50 per product. In 2009, inspection fees, registration fees and penalties collected totaled \$1,156,537. Table 5 summarizes the reported tons of ingredients distributed during the year. The term "exempt" represents ingredients sold to other manufacturers who pay inspection fees. "Non-exempt" represents ingredients for which the reporting firm pays the inspection fee. Table 6 reports the tons of Complete feed and Supplements/Premixes distributed during the year.

Analytical Variations

Regulatory officials use analytical variations (AV's) as a guide for issuing any type of violation with respect to the label guarantee. The total variation surrounding an analytical analysis of a feed product and comparing it to a label consists of (1) variation associated with the formulation and mixing in producing a feed; (2) variation of particle sizes in feed ingredients; (3) potential ingredient settling during transport; (4) variation associated with sampling; (5) variation associated with mixing and grinding samples; and (6) variation during analysis in the laboratory. Most variations associated with sampling, mixing, grinding, and analysis in the laboratory are known following many years of study to arrive at Official Methods. The AV's listed below allow for the inherent variability in those sources following the Official Methods with more weight given to the analytical areas of variation. The laboratory reported value of an analyte in a sample is reviewed with respect to the guarantee using the AV's below as a guide.
